## SMALL BUSINESS ADVANTAGE

The advantages of contracting with an Alaska Native Corporation (ANC) are:

- ANCs are exempt from the competitive threshold [13 CFR 124.506(b); FAR 19.805-1 (b)(2)].
- ANCs are eligible for sole source set-aside contracts of any dollar amount.
- ANCs are eligible for special rights under the A-76 Program [OMB Circular].
- As an ANC 8(a), Yulista may claim the past performance of sister companies and key management personnel during the evaluation period of an award per FAR 15.305(a)(2)(iii).
- TLS and TSL share a common General Manager and have significant affiliation, sharing common corporate support functions through their parent company Yulista Holding, LLC.
- DOD Contractors who offer subcontracts to ANC 8(a) firms receive 5% of the total value of the subcontract as an incentive per Section 504 of the Indian Financing Act of 1974 (25 U.S.C. § 1544).

## THE 8(A) ADVANTAGE

Tunista offers the following benefits to procurement officials:

- Direct contract awards allowed.
- Procurement process is simplified and accelerated.

### TUNISTA'S DIRECT AWARD PROCESS:

1. Select TLS for direct award (48 FAR 6.300-305)
2. Send Intent to Award letter with description of project to TLS SBA representative by KO or Specialist
3. SBA reviews project and determines TLS is capable of performing work
4. KO informs TLS and SBA that they may enter into negotiations and/or joint development of project plan
5. Once mutually acceptable terms are negotiated, contract is awarded SBA sends letter of acceptance to KO
