- ANC 8(a)'s may be sole-sourced on Federal contracts of any size, with no J&A, (\$100M DOD, \$25M Non DoD)
- Unlike other 8(a)'s, ANCs are not limited to the dollar limitations on manufacturing or other contracts for sole sources (Per 13 CFR 124.506(b))
- Sole source awards made to ANC 8(a) firms cannot be protested per 13 CFR 124.517(a)
- ANCs are exempt from the competitive threshold [13 CFR 124.506(b); FAR 19.805-1 (b)(2)]
- ANCs are eligible for sole source set-aside contracts of any dollar amount
- As an ANC 8(a), Yulista may claim the past performance of sister companies and key management personnel during the evaluation period of an award per FAR 15.305(a)(2)(iii)
- DOD Contractors who offer subcontracts to ANC firms receive 5% of the total value of the subcontract as an incentive per Section 504 of the Indian Financing Act of 1974 (25 U.S.C. § 1544)
