## MULTIPLE-AWARD CONTRACT TO BE LEVERAGED ACROSS ALL FEDERAL AGENCIES

GSA's One Acquisition Solution for Integrated Services (OASIS)+ Multi-Agency Contract (MAC) is a Government-wide, multiple-award, Indefinite Delivery, Indefinite Quantity (IDIQ) acquisition program for services. OASIS+ is designed to address the government's need for a full range of service requirements that integrate multiple service disciplines and ancillary services/products with the flexibility for commercial and non-commercial requirements to achieve a total solution.

OASIS+ is organized by "Domains" or functional groupings of related services spanning multiple NAICS codes. NAICS codes listed under the Domains are designed to align order requirements to qualified industry partners.

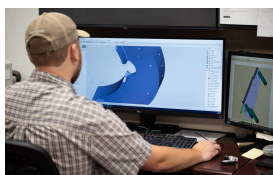

- Available to all federal agencies
- Designated Tier 3 Best-in-Class (BIC) contract, supporting agencies in meeting their spend under management objectives
- Aligns with Executive Order "Eliminating Waste and Saving Taxpayer Dollars by Consolidating Procurement"
- Supports classified and unclassified requirements
- Supports SB set-asides and sole source (direct) 8(a) orders
- Limited basis for protests on orders valued up to \$10M (\$25M for DoD, NASA, or Coast Guard)
- Access to pre-vetted industrial base of highly qualified contractors
- Allows agency direct access and/or offers GSA Assisted Acquisition Services support
- No contract ceiling or cap on awards (contract and task-order level)
- Allows Ancillary services and Other Direct Costs (ODCs)
- Allows all contract types – Fixed Price, Cost Reimbursement, T&M/LH, Hybrid
- Period of Performance 12/17/2024-12/16/2029  
Base Period with one five-year option:
  - Option 1: December 17, 2029 – December 16, 2034
- Low Contract Access Fee (CAF) of 0.15%
- Work can be performed world-wide
- Task order solicitation through a single platform, GSA eBuy



# OASIS+ Ordering Process

The General Services Administration (GSA) designed the OASIS+ contract for easy use and has provided two flexible options for placing task orders:

## Direct Order/Direct Bill

Customer agency Contracting Officer (CO) performs the acquisition and is responsible for all post-award contractual administration. This option requires the warranted CO to hold a Delegation of Procurement Authority (DPA). Obtaining a DPA is simple and is the first requirement a CO must meet to solicit, evaluate, award, and modify task orders under OASIS+.

## GSA Assisted Acquisition Services (AAS)

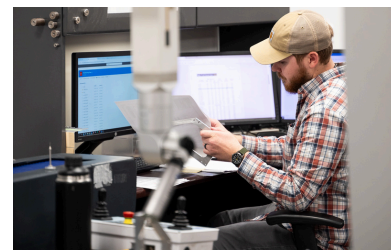
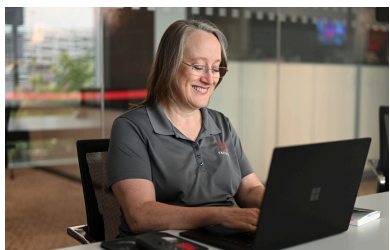
